#### **Payment Terms**

All fees are due upon registration. Payment options outlined in the table above. NSF cheques are subject to a \$30.00 fee payable to the Club. Members who submit NSF cheques to pay fees must pay future fees in cash or by certified cheque.

## **Registration Fees**

Player fees cover athletic privileges with the Club and include two to five pool times per week depending on age group, coaching, club swimsuit & t-shirt, and registration with Water Polo Canada through the Alberta Water Polo Association. Travel to out of province tournaments (generally for U12 and older) is in addition to registration fees. We will provide guidance on travel expectations at the beginning of the season.

Siblings who register with the Club, receive a 20% discount. Any discounts will be applied to lower priced fees in the event siblings are subject to different rates.

All forms must be completed and all payments submitted in order for this registration to be validated and accepted.

Registration funding subsidies are available for families who qualify, please contact the Registrar for more information.

Annual membership with the Club is open to anyone in Alberta. Those individuals without players in the program can purchase a non-player membership separately for \$200.

All members of the Club are expected to participate in fundraising (casinos, bingos, raffles, etc.) AND volunteer activities (e.g.: minor officiating, registration assistance, squad management, equipment, website, etc...). At registration, along with fee payment, members must submit a credit card to secure their \$500 fundraising/volunteer commitment fee. If you do not fundraise AND volunteer, your credit card will be charged the full amount. Our club much prefers that you PARTICIPATE rather than pay. Our club relies on the funds raised from participation in casinos and bingos. We are fined, and therefore lose money, if we are unable to fully staff our casinos and bingos. As part of your fundraising commitment, you will be assigned a minimum # of bingos/casinos once the fundraising schedule has been finalized (typically this is 2-4 bingos and 1 casino but is dependent on the # of members). The preference and expectation is that members work the bingos/casinos themselves. Failing that, it is YOUR responsibility to find a friend, family member or acquaintance to help you meet your commitment. You will be charged \$110 per missed bingo/casino commitment. Athlete families are also expected to raise a minimum of \$150 per family through fundraising activities like 60/40 or wine raffles, grocery card fundraising, etc. Optionally you can 'buy out' of your fundraising activities for \$200.

### **Full Season Withdrawal Policy**

Partial refunds are available for full season registrations only if you no longer wish to continue membership. To withdraw from the Club, you must give two weeks' notice in writing to the Board through the Club Registrar (registry@wildwaterpolo.ca). Any refund shall be calculated from the date of the receipt of such notification as follows:

On or before Sept 30 of the registration year -90% refund of registration fees On or before Dec 1 of the registration year -30% refund of registration fees After Jan 1 of the registration year -0% refund of registration fees

For any withdrawal after September 30, fundraising commitments (eg bingo /casinos) will still need to be worked. Alternatively you will be charged your remaining fundraising commitment fees. Costs of apparel and other items provided with the registration package will be deducted from any refund and all access cards must be returned to the Registrar. There will be NO refund of any travel credits earned by fundraising activities (e.g. casinos, bingos, etc).

## **Liability Release**

I/we acknowledge that Club assumes no liability for personal injury, damages, or loss of personal property while involved in or associated with any Club activity. Furthermore, I hold Club members, coaching staff, officers or duly authorized persons harmless from liability and hereby authorize the Club or its representatives to take the actions they deem necessary to correct, or attempt to correct, any situation which may result in personal injury, property damage or loss of personal property while involved with any Club activity.

### **Registration Contract**

In consideration for the Club agreeing to provide a position on a team for the above player, this is to confirm that I/we (the undersigned) have read and understand the Club regulations and agree to comply with them. Specifically, I/we agree to accept financial responsibility for the full fees of the above named player, in the form of cheques and post-dated cheques, and to accept responsibility for volunteer obligations. Overdue accounts will be charged 2% per month interest (24% per annum). In addition, collection (i.e. NSF charges) or legal costs to collect the account may be charged to the account as well.

### **Volunteer / Fundraising / Commitment Fee**

As a member of the Club over 18 years of age, I/we recognize I/we am/are obligated to participate in and assist in fundraising efforts, primarily bingos and casinos throughout the year as well as additional fundraising such as raffles, grocery cards, etc. and, as a member of the Alberta Water Polo Association, an Alberta Water Polo Association casino approximately every 18 months. Furthermore, I/we recognize that I/we am/are obligated to participate in and assist with a Club casino (if applicable) and other fundraising efforts that benefit the Club overall and which are endorsed by the Club Executive. I am also expected to volunteer to assist in the operations of the club (working extra bingo shifts, minor officiating, registration assistance, squad management, equipment, etc). In recognition of this obligation, a credit card # has been provided and I authorized to be charged in the event I/we do not fulfill my/our fundraising AND volunteer obligations. The fundraising/volunteer commitment and charges are outlined in the previous sections of this registration form.

## **Consent to Use Personal Information**

I/we understand that the Club collects personal information about each of its registrants, including name, address, email, telephone number(s), sex, age and date of birth. This information is used for the purposes of Club communications and coordination, ensuring that each participant competes in the appropriate category, that their name will be listed in that category in the results which are posted on the Club website and to determine demographics and market trends. The

information is also used by and disclosed to Water Polo Canada (WPC), Alberta Water Polo Association (AWPA), and Sport Canada for annual demographic reporting, registration and rosters, determining age groups and to communicate with participants about water polo programs, events and activities. Medical information forms collected are provided to coaches and trip chaperones when traveling outside of Calgary.

I/we understand that, by registering, I/we am/are consenting to the use of the personal information as necessary for Club operations. Furthermore, I/we confirm we will not use personal information disseminated by the Club for purposes unrelated to Club functions.

I/we understand that the Club, other water polo clubs, the AWPA and WPC have a valid interest in taking photographs, videotape, or digital recordings of me/us during regular practices and competitive water polo activities, and to use these in any and all media to promote the Club and the sport of water polo, and I/we consent to this. I/we waive any rights of compensation and ownership thereto.

I/we am/are aware that by giving this consent, I/we am/are permitting my/our name/names, my/our photos and my performance results to be posted on the Club, AWPA and WPC websites or publications and other venues.
